Objective and Investment Policy

Amundi EUR Corporate Bond Active UCITS ETF Acc is actively managed with reference to the Bloomberg Euro Aggregate Corporate Index (the Benchmark). It seeks to outperform the Benchmark (after deduction of applicable fees) over a recommended investment horizon of at least 3 years, without targeting a specific level of outperformance. The sub-fund is primarily exposed to the issuers comprising the Benchmark. However, as management is discretionary, the sub-fund may also be exposed to issuers not included in the Benchmark. The sub-fund monitors its risk exposure relative to the Benchmark. Nevertheless, the extent of deviation from the Benchmark may be limited. 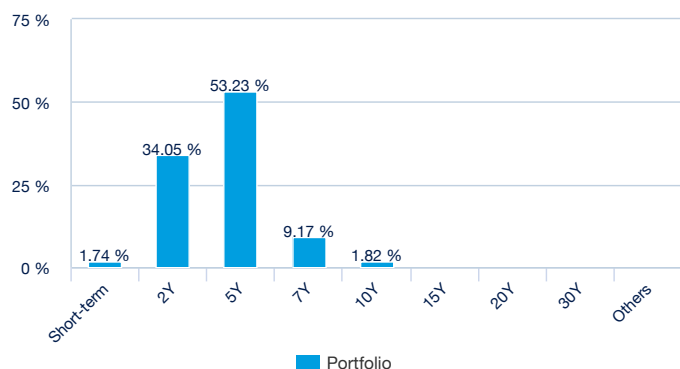

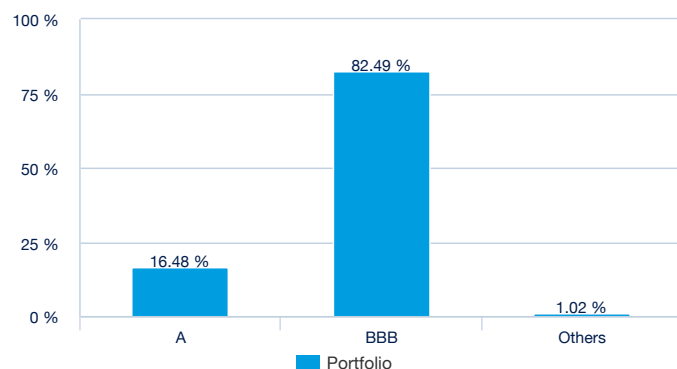

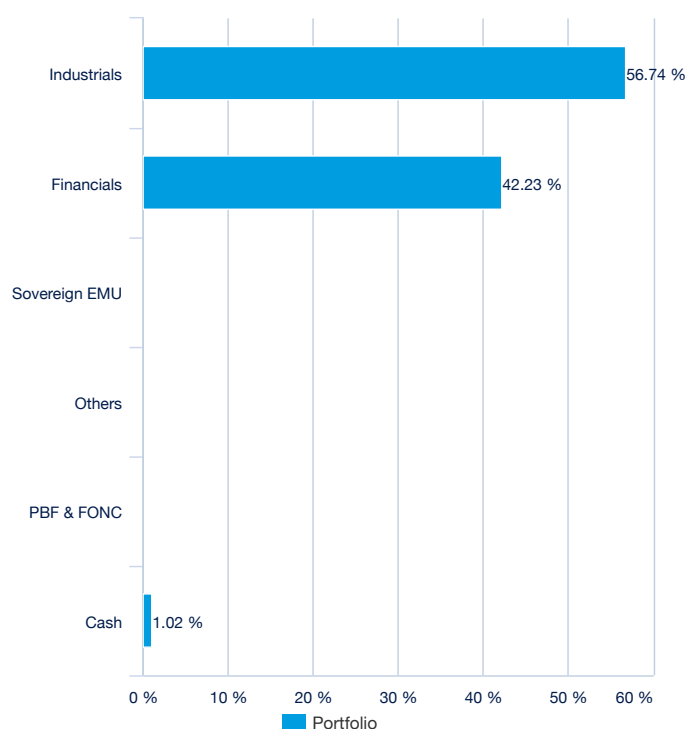
By maturity (Source: Amundi)



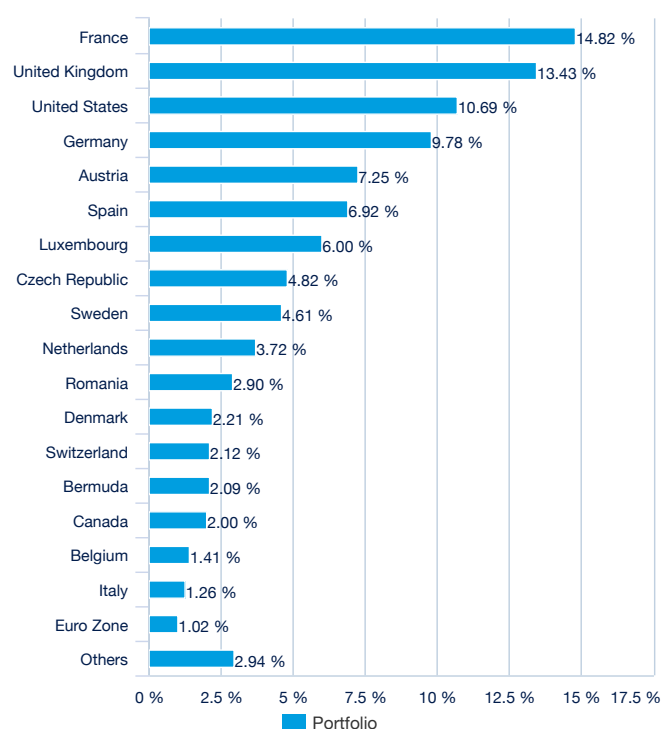
