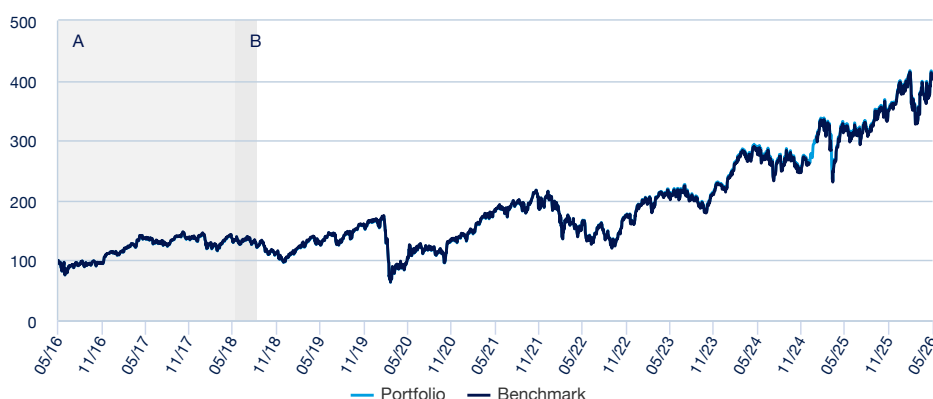

Description of the Index

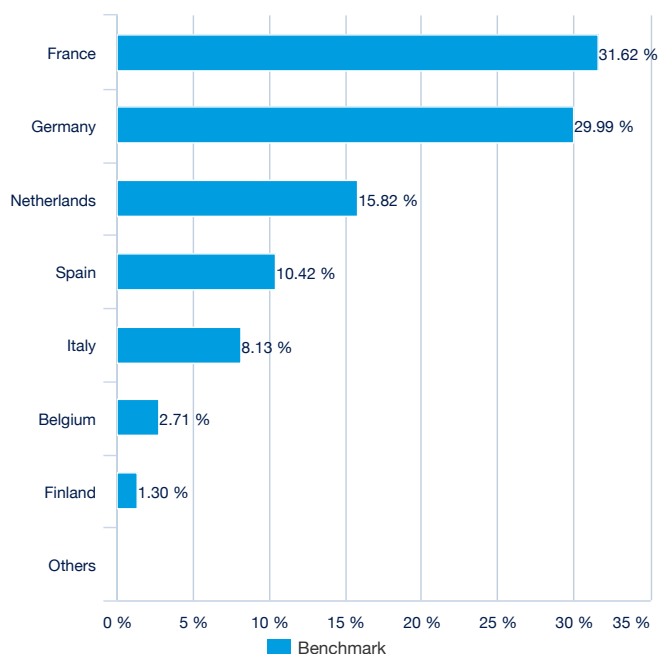

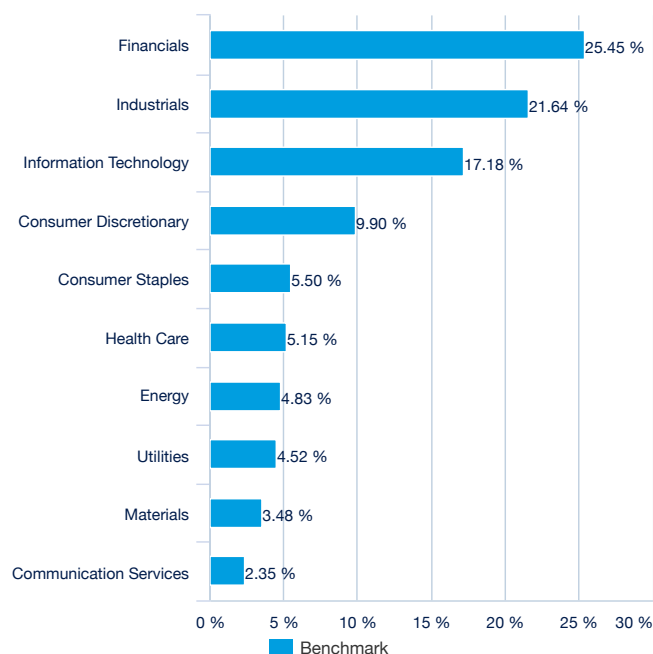
