What is this product?

Type: Shares of a Sub-Fund of Lyxor Index Fund, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The Fund is an index-tracking UCITS passively managed. The investment objective of the Fund is to track both the upward and the downward evolution of the MSCI ACWI IMI Digital Economy & Metaverse ESG Filtered Index (the "Benchmark Index") denominated in US Dollars (USD), while minimizing the volatility of the difference between the return of the Fund and the return of the Benchmark Index (the Tracking Error). The anticipated level of Tracking Error in normal market conditions is indicated in the prospectus.

The Benchmark Index aims to represent the performance of companies that are expected to derive significant revenues from the digital economy value chain including the metaverse ecosystem and exclude companies which are Environmental, Social and Governance ("ESG") laggards relative to the theme universe, based on an ESG rating. The ESG rating methodology is based on ESG key issues including but not limited to water stress, carbon emissions, labor management or business ethics. The Benchmark Index uses a "Best-in-class" approach, i.e., bottom quartile companies by ESG industry-adjusted rating are excluded from the theme universe. Limits of the methodology of the Benchmark Index are described in the prospectus of the Fund through risk factors, such as the market risk linked to controversies and the risks linked to ESG methodologies and to ESG score computation.

The Benchmark Index is a net total return index. A net total return index calculates the performance of the Benchmark Index constituents on the

basis that any dividends or distributions are included in the Benchmark Index returns after withholding tax retention.

The Fund seeks to achieve its objective via a direct replication, by investing primarily in the securities comprising the Benchmark Index. To optimize the Benchmark Index replication, the Fund may use a sampling replication strategy. The potential use of this technique is published on Amundi's website: www.amundi.lu.

In addition, the indicative net asset value is published on the Reuters and Bloomberg pages of the Fund, and might also be mentioned on the website of the stock exchanges where the Fund is listed.

Intended Retail Investor: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment over the recommended holding period and who are prepared to take on a high level of risk to their original capital.

Redemption and Dealing: Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the Lyxor Index Fund prospectus.

Distribution policy: As this is a non-distributing share class, investment income is reinvested. The accumulation share automatically retains, and reinvests, all attributable income within the Sub-Fund; thereby accumulating value in the price of the accumulation shares.

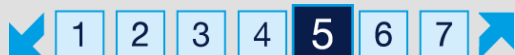

The risk indicator assumes you keep the product for 5 years.

What happens if Amundi Asset Management is unable to pay out?

The assets of the Sub-Fund do not belong to the assets of the Fund Manager, the assets of the Sub-Fund are in the custody of the Custodian bank. The Fund is not responsible for the obligations of either the Fund Manager or other investment funds managed by the Fund Manager. The Sub-Fund makes securities investments, payment restrictions on organizations issuing securities or their insolvency affect the Sub-Fund's assets and the Sub-Fund's payment obligations to unit holders. The price of investment units issued to the Sub-Fund is not covered by the guarantee of the Investor Protection Fund (BEVA) or the National Deposit Insurance Fund (OBA). The BEVA guarantee is only available to the investor in the case of the liquidation of the BEVA member securities account manager that registers the investment units.

What are the costs?

How long should I hold it and can I take money out early?

Recommended holding period: 5 years is based on our assessment of the risk and reward characteristics and costs of the Sub-Fund.

This product is designed for medium-term investment; you should be prepared to stay invested for at least 5 years. You can redeem your investment at any time, or hold the investment longer.

Order schedule: Orders to redeem shares must be received before 06:30 PM Luxembourg time no later than one (1) Business Day before the Valuation Day. Please refer to the Lyxor Index Fund Prospectus for further details regarding redemptions.
